Researchers from third countries who to carry out scientific research in the Community, as mentioned by the Recommendation nº 2005/761/CE, of the European Parliament and of the Council, of 28 September, which was established to facilitate the issuance by Member States of the uniform short-stay visas for researchers/investigators from third countries traveling for scientific research in the community	Art. 62º, nº3, c)	0€
Representatives of non-profit organizations, up to 25 years old, participating in seminars, conferences, sports, cultural or educational events organized by non-profit organizations.	Art. 62º, nº3, d)	0€

Art. 62º, nº 4 – Exemptions from the payment of the administrative costs regarding to the request of Visa:

Visas granted to foreign nationals covered by scholarships awarded by the Portuguese State.	Art. 62º, nº4, a)	0€
Nationals of third countries, who are family members of citizens of the European Union or the European Economic Area exercising their right to free movement, including family members in this context.	Art. 62º, nº4, b)	0€
